**Motion was made by Supervisor McBurney and seconded by Supervisor Schreffler to have Supervisor Bechtel serve as the temporary Chairman of the Board of Supervisors. Vote called. Motion carries 4-0.**

**Motion was made by Supervisor Schreffler and seconded by Supervisor McBurney to have Wendy Wentzel serve as temporary Secretary for the Township. Vote called. Motion carries 4-0.**

**CALL TO ORDER** - Meeting was called to order by Temporary Chairman Bechtel at 7:06 pm. followed with the Pledge of Allegiance.

**ROLL CALL** - Supervisors Bechtel, Bruner, Schreffler and McBurney are present along with Secretary Wendy Wentzel and Roadmaster Corey Stazewski. Supervisor Paul was absent. Solicitor Bruce Warshawsky and Engineer Tom Wilson were not required to attend.

**PUBLIC COMMENT PERIOD:** No comments from the public.

**ELECTION OF CHAIRMAN** – Motion was made by Supervisor Bruner and seconded by Supervisor Schreffler to nominate Supervisor Bechtel as Chairman of the Halifax Township Board of Supervisors. Vote called. Motion carried 4-0.

**ELECTION OF VICE CHAIRMAN** – **Motion** was made by Supervisor McBurney and seconded by Supervisor Schreffler to nominate Supervisor Bruner as Vice Chairman of the Board of Supervisors. Vote called. Motion carried 4-0.

**APPOINTMENT OF SECRETARY-TREASURER** – **Motion** was made by Supervisor Schreffler and seconded by Supervisor Bruner to nominate Wendy M. Wentzel to serve as Secretary/ Treasurer for 2016. There were no other nominations. Vote called. Motion carried 4-0.

**APPOINTMENT OF OPEN RECORDS OFFICER** – **Motion** was made by Supervisor McBurney and seconded by Supervisor Schreffler to appoint Wendy M. Wentzel to serve as the Township’s Open Records Officer. Vote called. Motion carried 4-0.

**APPOINTMENT OF ROADMASTER** – **Motion** was made by Supervisor McBurney and seconded by Supervisor Schreffler to appoint Corey Stazewski to serve as Township Roadmaster for 2016. Vote called. Motion carried 4-0.

Vote called. Motion carried 4-0. **Motion** was made by Supervisor McBurney and seconded by Supervisor Schreffler to pay Jay Bechtel at the rate of \$13.25/hour. An amendment to the **Motion** was made by Supervisor Bruner and second by Supervisor McBurney to pay Jay Bechtel \$13.50/hour instead of \$13.25/hour as a permanent part time employee. Vote called. Motion carried 3-0-1. Chairman Bechtel abstained from voting. Vote called on the original motion with the amendment. Motion carried 3-0-1. Chairman Bechtel abstained. **Motion** was made by Supervisor Schreffler and seconded by Supervisor McBurney to approve the hourly rate of pay for CDL plow operators at the rate of \$14.00/hour, Non-CDL plowers at \$12.00/hour, CDL drivers at the rate of 12.00/hour and laborers’ rate set at \$11.00/hour for the Township. Vote called. Motion carried 4-0.

**APPROVAL OF PAY PERIODS – Motion** was made by Supervisor Bruner and seconded by Supervisor McBurney to approve the following pay periods. Vote called. Motion called 4-0.

**APPOINTMENT OF ENGINEER & APPROVAL OF FEE SCHEDULE – Motion** was made by Supervisor Schreffler and seconded by Supervisor Bruner to reappoint Kurowski & Wilson (K & W) to serve as the Township Engineer firm contingent upon the fee schedule for 2016 being the same as the 2015 Fee Schedule. Vote called. Motion carried 4-0.

**APPOINTMENT OF UCC & APPROVAL OF FEE SCHEDULE – Motion** was made by Supervisor Bruner and second by Supervisor McBurney to appoint Light-Heigel and Associates

as the UCC for the Township for 2016 contingent upon the fee schedule remaining the same as 2015. Vote called. Motion carries 4-0.

**APPOINTMENT OF SEO & APPROVAL OF FEE SCHEDULE** – **Motion** was made by Supervisor Bruner and seconded by Supervisor McBurney to retain Light-Heigel and Associates as the Township’s primary SEO for 2016.
